

# Check Out Your Child's Vision Care Program

As a member of a qualified health plan with Blue Cross and Blue Shield of Illinois (BCBSIL), members up to 19 years old are eligible for pediatric vision care benefits administered by EyeMed Vision Care.

## Pediatric benefits for members up to 19 years old include:

- Coverage for one eye examination every 12 months
- Spectacle lenses or contact lenses<sup>2</sup> and a frame allowance every 12 months

Note that for HSA-eligible plans, the member must meet the plan's deductible before benefits begin for spectacle lenses, contact lenses and frames.

**Remember:** When you visit an EyeMed network provider, your copayment is due on the day of your visit.

#### How do I locate an EyeMed provider?

The EyeMed network consists of thousands of independent and retail providers, including national brands like LensCrafters®, Pearle Vision and Target Optical®. You can also visit and use contactsdirect.com and glasses.com, as well as Ray-Ban. com., TargetOptical.com., and LensCrafters.com.

### Does my child need a referral or ID card?

You don't need a referral. Simply visit any EyeMed provider and show your BCBSIL ID card, or just provide your name and date of birth, to access your vision care benefits and discounts.

# Are there discounts on other vision services and materials that aren't covered?<sup>3</sup>

You receive extra discounts above your BCBSIL plan benefits, including:

- A standard contact lens fit and follow-up exam for \$40 or less
- 40 percent off additional pairs of prescription glasses
- 20 percent off some items not covered by the plan

### Are there any exclusions?

The following are some of the items **not covered** as part of the vision care program. Refer to your benefits booklet for a full list.

- Medical treatment of eye disease or injury<sup>4</sup>
- Vision therapy
- Services performed by a provider who is not in the EyeMed network
- Replacement of lost eyewear
- Services not performed by licensed personnel
